- Show onsite septic system, include tank, piping and drain-field [Site Plan Sheet 1 of 1]
- Show onsite water service, include meter and service line [Site Plan Sheet 1 of 1]
- Provide an approved Tacoma Pierce County Health Department [TPCHD] site plan. The site plan approved by TPCHD must match the site plan reviewed by the City of Puyallup [Site Plan Sheet 1 of 1]
- The application state that there will be 3,000 +/- disturbed area. If true, a stormwater report must be submitted to the city for review. See 2014 update to the 2012 Stormwater Management Manual for Western Washington (SMMWW)
