 - 2) Show on site septic system, include tank, piping and drain-field.
 - i. TPCHD approved septic plan added
 - 3) Show onsite water service, include meter and service line
 - i. Water meter location and service line added to new site plan and included in the TPCHD approved plan.
 - 4) Provide an approved Tacoma Pierce County Health Department [TPCHD] site plan. The site plan approved by TPCHD must match the site plan reviewed by the City of Puyallup
 i. TPCHD approved septic plan added
 - 5) The application states that there will be 3,000 +/- disturbed area. If true, a stormwater report must be submitted to the city for review. See 2014 update to the 2012 Stormwater Management Manual for Western Washington (SMMWW)
 - i. Applicant was incorrect in disturbed area calculation. Correct calculation is 684 SF.
