- A3.5 - Provide distance to show minimum separation above roof.

- A3.5 - Provide duct material and manufacture specification of clearance from framing members.

Consider heat temperature from ovens to assure spacing and duct material is adequate.

- A3.5 - Provide bracing plan on how duct will be braced from Powder Coat booth to roof penetrations per building code.

- A3.5 - Provide sealed Mechanical Engineer plans for mechanical work.

Conditions

The items listed in the table below are conditions of the permit that do not need to be addressed on the next resubmittal of plans but will need to be fulfilled at some point in the permit review process. The "Condition Category" indicates the approximate phase of the permit process by which the condition must be fulfilled in order for the City to continue processing this permit. For some conditions that require submittal of a document to the City, those documents can be submitted via the Conditions Section of the City's permit portal.
