- For each submittal item listed re-submit a new version of the submittal item by clicking the "New Version" button next to the file name of the original file submitted. DO NOT click the 'browse' button unless the document you are submitting for that submittal item is not a new version of the originally submitted document. Click 'Upload Documents' at bottom of the page.

- Will need to show the travel distance to an accessible restroom for this proposed building per 2018 IBC section 2902.3.3 of the WA. ST. amendments.

Note on the A1.0 plan page.

- All racking would be required to have a separate permit. And should be so noted on the plans for clarity. Note on page A2.0.
- This information needs to be submitted for this permit review as part of documents.
- Note on page \$1.1 of plans.
- This information needs to be submitted for this permit review as part of documents. Note on page S3.1 of plans,
- A soils report was not submitted as part of the permit documents for this permit for reference to this comment. Note on page S3.1, at detail F4 of plans.

Conditions
