Referring to your Building review notes:

- 1) Discrepancy:
 - a) Please replace the following pages with the new and final location for the rough opening of the lockers in the Puyallup Library project.
 - i) Page 4 of this document replaces page 2 of the City Stamped Plan_Rough opening plan (Flattened)
 - ii) Page 5 of this document replaces pages 3 and 5 of the stamped plan
 - iii) Remove page 4 of the stamped plan in its entirety (they were field notes and should not have been included
- 2) Final Location- See new page 2
- 3) Welding WABO- We have a WABO welder on-staff- a copy of his WABO card will be provided to the inspector and engineer of record

LAMB will need flexibility to adjust the opening +/- a couple of inches left or right and up or down to accommodate the exterior elevation 2'-0"+ dimension. There is obviously a height restriction due to the beam.
