- 6- HYDRO TEST, TWO INSPECTIONS WILL BE REQUIRED 2HRS APART. CALL TO SCHEDULE TIMES.
- 7- FIRE PUMPS WILL BE REQUIRED TO BE TESTED AND WITNESSED BY INSPECTOR.

CONTRACTOR MUST BE PRESENT AT INSPECTIONS.

Permit is valid 180 days from date of issuance. Permit validity is subject to all adhering to all applicable codes, ordinances and standards, and conditions of this permit.
