- 4 ; provide all back flow certs. at time of next inspection.
- 5 ; insulate all hot water supply lines in boiler room.
- 6 ; complete all T.P.R. valve drains to mop sink.
- 7 ; complete drain for back flow to mop sink.
- 8 ; complete all permanent signage at exit doors ,restrooms, changing rooms, occupant load signage as per City approved plans.
- 9 ; complete shower trim at public showers.
- 10 ; complete plumbing boots at sinks at restrooms.
- 11 ; complete ceiling at electrical room.
- 12 ; complete accessible benches in restroom as per City approved plans.
- 13 ; complete urinal 17" max. a.f.f. in restroom as per City approved plans.
- 14 ; complete vertical grab bars at mens & womens restroom 39"-41" as per City approved plans.
- 15 ; complete door hardware at vestibule front door.
- 16 ; complete stairs at pool as per Detail 6 of page AQ2.1

- 21 ; paint all new gas pipe on roof and next to gas meter.
- 22 . need to review balance reports and final letters at next inspection. (not ready)
