# **RE: INSPECTION PUNCHLIST FOR PERMIT PRCCP20220189**

To Whom It May Concern:

City of Puyallup's Development Engineering has completed, at your request, a final inspection of the above referenced permit number.

The following is a list of outstanding items that must be completed prior to Engineering's final acceptance of the work. Please note that this list has been broken into two sections:

Section A are considered life/safety items that must be completed for the utilities to operate and be maintained as intended. Therefore, Section A must be completed and accepted before Development Engineering can consider the project adequately complete and to allow issuance of an Occupancy Permit.

**Section B** are punchlist items, and as such, do not have to be completed prior to occupancy. However, the items listed under Section B must be guaranteed to be completed within 90 days from the date of this letter. The City of Puyallup requires an assignment of funds in the amount of \$10,000.00 to guarantee completion of the punchlist items.

### SECTION A

(ITEMS WHICH MUST BE COMPLETED PRIOR TO OCCUPANCY)

## STORM:

- Provide the City with a letter from the design engineer certifying the proper installation of permanent stormwater controls and compliance with the stormwater site plan.
- Parking Lot C Punchlist item
  - Add straw and seed to all bare areas where the electrical was installed.
- Parking Lot B Punchlist:
  - Install (core drill) inspection port for flow control MH w/ concrete collar.
  - Clean debris out of flow control MH.
  - Locate and raise to FG existing CB near daycare.
  - Install mesh screen (1/2" on bottom & 1" on top) on tees in bio swale.

- Install 1 hand hold in riser for detention pipe.
- Mount ladders in 7 risers for detention pipe.
- Clean foam debris out of detention pipe.
- Install missing nuts for detention riser lids to be bolted down.
- Provide the recorded easement for the preservation of the full dispersion flow path area.

#### STREET:

- Parking Lot C Punchlist items:
  - AR seal all asphalt over cuts and rough spalled areas where water will seep through.
- Parking Lot B Punchlist:
  - AR seal all asphalt over cuts, new joints, and rough (spalled) areas where water will seep.
  - Install 6" concrete collar around 2ea. MH lids in the planter and raise to grade.

# **MISCELLANEOUS:**

• This project owes \$180 in overtime inspection fees.

# **SECTION B**

(ITEMS COVERED BY AN ASSIGNMENT OF FUNDS TO ALLOW OCCUPANCY)

### STORM:

- Provide the City with a recorded copy of the Stormwater Management & BMP Facilities
  Agreement. With the operation and maintenance manual described in item 3 as a recorded

### **MISCELLANEOUS:**

- Provide the City with an electronic version of the record drawings in PDF format and in AutoCAD Map 2007 or newer in State Plane South Projection format.
- Schedule a landscape inspection with the planning department. Contact Chris at cbeale@puyallupwa.gov or 253-841-5418

Upon completion of the items listed under Section B, the City will release the assignment of funds back to you. If any or all the items listed under Section B are not completed within 90 days of the date of this letter, the City has the right to use the funds being held to complete the remaining work.
