- 2 For each submittal item listed re-submit a new version of the submittal item by clicking the "New Version" button next to the file name of the original file submitted. DO NOT click the 'browse' button unless the document you are submitting for that submittal item is not a new version of the originally submitted document. Click 'Upload Documents' at bottom of the page.
- 3 If any re-submittal fees have been assessed, you will need to pay your resubmittal fee at the time of resubmittal. Your resubmittal will not be processed until the fee has been paid.

Otherwise, please provide an alternative location or design. [SITE PLAN, sheet 6 of 8] - Uniformed police officer required at the intersection of 9TH ST SW and 39TH AVE SW. Depict UPO and revise advanced warning signs accordingly. [MH-122 Access] - Uniformed police officer required at the intersection of 9TH ST SW and 39TH AVE SW. Depict UPO and revise advanced warning signs accordingly. [HH-818 Access] - Eastbound thru traffic on 39TH AVE SW shall be merged into a single lane before the intersection with 9TH ST SW to prevent queuing in the intersection. Revise the site plan accordingly. [TCP, HH818 Access] - Place a RIGHT LANE CLOSED AHEAD advanced warning sign for northbound traffic on 7TH ST SW before the intersection of 39TH AVE SW. [TCP, HH616 Access] - Place a RIGHT LANE CLOSED AHEAD advanced warning sign for northbound traffic on 7TH ST SW before the intersection of 39TH AVE SW. [TCP, Aerial Placement Sheet 1] 			

Conditions
