#### **Re-submittal Instructions**

Letter of transmittal must be submitted to the 'resubmittal form' item listed in the submittal items list. Avoid using "upload additional docs" unless there is NO submittal item available for your document. Please Note: If you do not resubmit as instructed your re-submittal will be rejected. If you have any questions about how to resubmit, please contact the permit center.

- Log in to your permits portal and navigate to the status page for this permit under the "My Items" tab by selecting the "Upload Submittals" button under the permit number.
- For each submittal item listed re-submit a new version of the submittal item by clicking the "New Version" button next to the file name of the original file submitted. DO NOT click the 'browse' button unless the document you are submitting for that submittal item is not a new version of the originally submitted document. Click 'Upload Documents' at bottom of the page.
- If any re-submittal fees have been assessed, you will need to pay your resubmittal fee at the time of resubmittal. Your resubmittal will not be processed until the fee has been paid.

- FIRST REVIEW: Work within WSDOT's jurisdiction requires a site plan stamped with WSDOT's approval. If you have not received WSDOT approval, please email your plans to olympicregionutilities@wsdot.wa.gov prior to applying with the City of Puyallup.

SECOND REVIEW: The revised site plan and traffic control plan are not stamped with WSDOT approval. Please submit a site plan and traffic control plan with WSDOT's approval stamp or correspondence with WSDOT indicating that the submitted site plan and traffic control plan have been approved. If WSDOT provided any comments on the plans, please submit the comments to the City for review upon the next submission. [Yianni Charitou @ 10/05/2023 8:06 AM]

- Place a FLAGGER (W20-7A) advanced warning sign for westbound traffic on 35TH AVE SE before the 5TH ST SE intersection. [TCP, sheet 1 of 4]
- Correct to 5TH ST SE. [TCP, sheet 1 of 4]
- Reorient traffic cones after the utility crossing to allow westbound traffic on 35TH AVE SE to turn north on S MERIDIAN before the traffic island. [TCP, sheet 2 of 4]
- Correct to S MERIDIAN [TCP, sheet 3 of 4]

#### **Conditions**

The items listed in the table below are conditions of the permit that do not need to be addressed on the next resubmittal of plans but will need to be fulfilled at some point in the permit review process. The "Condition Category" indicates the approximate phase of the permit process by which the condition must be fulfilled in order for the City to continue processing this permit.
