- Will landscaping (trees and shrubs) be allowed in the landscape yard shown on the eastern side of the driveway location? There appears to be a sewer and water easement. Landscaping is required per code.

<p>- 1. What is the height of the building to the lowest eve? This project may be required to have two approved aerial fire apparatus access roads.</p> <p>2. A Fire Sprinkler System will be required, as per the notes before provide Riser Room, F.D.C, P.I.V, and Fire Hydrant locations. A Fire Hydrant is required to be within 10-15' of the F.D.C.</p>
