The northern property line of tax parcel 0419095006 was depicted correctly on the last submittal and has since been incorrectly redrawn without the support of a survey. Please depict the right-of-way line in its true location or provide a survey to support the right-of-way line adjustment and anchor placement. [SITE PLAN, sheet 6 of 10]</p>
