- 2 For each submittal item listed re-submit a new version of the submittal item by clicking the "New Version" button next to the file name of the original file submitted. DO NOT click the 'browse' button unless the document you are submitting for that submittal item is not a new version of the originally submitted document. Click 'Upload Documents' at bottom of the page.

Provide a copy of a recorded temporary utility easement granted to PSE from the property owner for the placement of utility pole P1A on private property. [SITE PLAN, sheet 1 of 1]</p> <p>SECOND REVIEW COMMENT: A 10x10' DG easement has been depicted on the plan to include the area of the down guy. Please submit a copy of the utility easement for review. The easement must include the area of the down guy and the proposed utility pole P1A since both are located on private property. Alternatively, the applicant may wait to resubmit plans after the property's E PIONEER frontage has been dedicated to the public right-of-way. [SITE PLAN, sheet 1 of 1]</p>			

Conditions
