1. * Final approval by the Building Official is required prior to use or occupancy.* Work shall not proceed until the inspector has approved the stages of construction.* Surface storm water shall be diverted from the building site and shall not drain onto adjacent properties.* I hereby acknowledge that I have read this Permit/Application, that the information given is correct; that I am the owner or the duly authorized agent of the owner; that plans submitted herewith are in compliance with all applicable city, county and state laws and that all construction will proceed in accordance with said laws. This permit shall expire if work is not commenced with 180 days or if the work is suspended for a period of 180 days. Permits expire two years from issuance. * By leaving the contractor information section blank, I hereby certify further that contractors (general or subcontractors) will not be hired to perform any work in association with this permit. I also certify that if I do choose to hire a contractor (general or subcontractor) I will only hire those contractors that are licensed by the State of Washington. If you are a property owner, contractor or permittee and you are paying for someone to perform the work, they must have a valid contractor registration and the person(s) installing plumbing inside a structure must meet the plumbing certification requirements. - 2. 1. Fire Alarm System must be actively monitored.
- 2. An emergency egress / exit sign light test will be conducted. Power to the lighting circuit must be shut off and all emergency lighting must turn on and illuminate exit paths.
- 3. Theft is a big issue for all companies, Exit doors must be unlocked and not blocked by displays or curtains.
- 4. Exit signs must be visible and not blocked by any objects.
- 5. Fire Extinguishers must be available every 75' of travel.
- 6. Occupant load and travel distance to required exits will be field verified.

Permit is valid 180 days from date of issuance. Permit validity is subject to all adhering to all applicable codes, ordinances and standards, and conditions of this permit.
