- 1 Log in to your permits portal and navigate to the status page for this permit under the "My Items" tab by selecting the "Upload Submittals" button under the permit number.
- 2 For each submittal item listed re-submit a new version of the submittal item by clicking the "New Version" button next to the file name of the original file submitted. DO NOT click the 'browse' button unless the document you are submitting for that submittal item is not a new version of the originally submitted document. Click 'Upload Documents' at bottom of the page.
- 3 If any re-submittal fees have been assessed, you will need to pay your resubmittal fee at the time of resubmittal. Your resubmittal will not be processed until the fee has been paid.

<p>- Depict the anchored guy wire on ROW PROFILE: P01 and its spatial position relative to the BNSF Railway right-of-way line. The City does not review, approve, authorize, or permit work in the BNSF Railway right-of-way. A BNSF Railway Company Pipeline or Wire Line permit may be required if the applicant anchors the proposed P01 guy wire in BNSF right-of-way. The contractor will be responsible to present a copy of the BNSF permit upon request of the City Inspector. [SITE PLAN, sheet 1 of 1]</p> <p>- BE PREPARED TO STOP and FLAGGER AHEAD advanced warning signs required for all directions prior to the intersection when a UPO is proposed at the intersection. Revise all pages of the traffic control plan accordingly. [TCP, all pages]</p>
