Revise the project description to include the additional scope as depicted or include a callout that the work on the north side of 15TH AVE SE shall be permitted separately. [SITE PLAN, sheet 3 of 3]</p> <p>- Since the City standard traffic control plans do not match the lane configuration, please submit a site-specific traffic control plan designed and signed by a Traffic Control Specialist (TCS). The plans should be designed to City traffic standards and include the TCSs name, TCS number, and contact information. Traffic control plan should include all lane, shoulder, roundabout, and intersection closures. [TRAFFIC CONTROL PLAN, sheet 1 of 1]</p>
