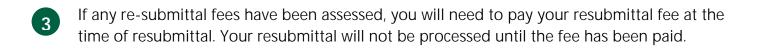
Re-submittal Instructions

DO NOT click the 'browse' button unless the document you are submitting for that submittal item is not a new version of the originally submitted document.
