- Additional Submittal Item Required: Provide a site plan that matches the draft civil plans. The building permit submittals should match the draft civil set, especially regarding building location, size, footing placement, and utilities. [Yianni Charitou @ 05/13/2024 10:39 AM]
- Address conflict between proposed slab on grade and existing wall at the southwest corner. Compare with draft civil plans for the placement of the structure. Address discrepany between civils and building plans. [CONSTRUCTION PLAN SET, sheet S2.1A, page 3 of 5]
- Depict and label existing retaining wall and the distance from the proposed structure. [CONSTRUCTION PLAN SET, sheet S2.1A, page 3 of 5]
- Revise the site plan to depict new and existing utilities in and around the proposed structure. In particular, depict and label the distance to the new 8" storm main, new storm drains, and the two existing sewer lines referred to as "plant drain" and standard sewer main on the civil plans. Address any conflicts between the proposed structure footings and the new/existing utilities. The City of Puyallup does not maintain utility records on private property. The property owner is responsible for providing the utility information to the City during development. [CONSTRUCTION PLAN SET, sheet S2.1A, page 3 of 5]
- Label the equipment in this area for reference. [CONSTRUCTION PLAN SET, sheet S2.1A, page 3 of 5]
- Label the wall at this location as new or existing. If this is a retaining wall, provide the location of the stormwater footing drains to avoid conflicts with the proposed footings. [CONSTRUCTION PLAN SET, sheet S2.1A, page 3 of 5]

- Provide Site Plan
- Clarify scope of work. Is this a remodel of an existing building? If so, show existing building on the site plan and in plan set.

#### **Conditions**

Prior to Completion	Building permit PRCTI20240601 cannot be issued until civil construction permit PRCCP20240183 is issued first.  The City shall not be held liable for any conflicts that arise between the approved building plans and approved civil construction plans since the building permits were issued prior to civil approval. Ken Cook authorized that this condition be changed from a prior to issuance condition, per normal procedures, to a prior to completion condition in order for work to begin on the building permit while the civil construction permit is under review.
