See marked-up document(s) for review comment: [1062 PLANS, Structural Design Criteria note C3] and [STRUCTURAL CALCS] - The engineer of record's signature must be placed directly over the seal. See the WAC 196-23-070, item 1D. See marked-up document(s) for review comment: [1062 PLANS, structural sheets] and [STRUCTURAL CALCS]			

Conditions
