Click 'Upload Documents' at bottom of the page.

- Where a curb exists, the lateral offset of all vertical obstructions at intersections shall be a minimum of 3' from the face of the curb to the face of the vertical obstruction. Provide the distance of the proposed pole to face of curb. Relocate the pole as necessary to account for the offset requirement. [SITE PLAN, sheet 5 of 6]			

Conditions
