We are hoping you could assist with the appropriate container size and access. We are proposing a four (4) unit storage building with possible workspace area. The building footprint is 45ft x 70ft, 3,150 SF, plus the

additional mezzanine totals a gross floor area of 3,988 SF on a 10,000 SF site. The site is currently vacant at 111 5TH ST SE, parcel 7285000112, in the City of Puyallup.

For this Conditional Use Permit application for Light Industrial, project number PLCUP20220162, we received City comment to specify where (if any) trash and recycling receptacles are being placed and use Public Works Design Standards Section 208 Pollution Prevention for trash enclosure requirements. The site plan and elevations (attached) may not fit a trash enclosure by the parking lot. May each unit roll out a their own 35-gallon container from inside the unit to the street?

We are in need of your feedback to find a waste disposal solution. We look forward to hearing from you.
