- Please include the maximum dimension for the opening between treads per the 2021 Washington State Building Code, section 1011.5.5.3. Typical for Stairs 1, 2, and 3. [Reference the marked-up document: CONSTRUCTION PLAN SET, sheet WR1.1]
- Please remove all references to the CBC. [Reference the marked-up document: CONSTRUCTION PLAN SET, sheet WR1.1]
- Please correct this detail call-out. The correct detail appears to be Detail 5. [Reference the marked-up document: CONSTRUCTION PLAN SET, sheet WR1.2]
- Please correct this detail call-out. The correct detail appears to be Detail 7. [Reference the marked-up document: CONSTRUCTION PLAN SET, sheet WR1.2]
