"In the event a nonconforming sign is removed, replaced, or structurally altered, pursuant to installation of a new sign, all applicable sections of the Puyallup sign ordinance (this chapter) shall apply to the new proposal. The alteration or enlargement of existing signs shall not increase the degree of nonconformity, in terms of number, size, height, setback, or any other applicable regulation."
