- Provide plumbing calculation to show additional bathroom fixtures are not required for this floor.

- Sinks are reflected at 36 inches from the floor. Per 2017 Washington State Accessibility Code, Section 606.3 sinks are required to be a maximum of 34" above the floor.

(Construction Documents, Sheet A6.1, Interior Elevation 6)

- 1. The reflective ceiling plan does not show light fixtures with battery backup? Page A4.1 shows the option in the key but not on the plans.
