Then locate your permit number and click on "request inspection". This will pull up a list of inspection types associated with your permit. Click on the desired inspection type and then click Next Step to begin the inspection request

Standard Conditions:

- 1. Provide plans and permit on site for inspection.
- Cover and final inspections are required.
- Fire watch is required when sprinkler system is out of service in existing buildings.

- Contractor required at all inspections.
- NFPA placards required.
- In existing buildings all upright fire sprinklers to remain, do not remove.
- In existing buildings all required service and maintenance to be completed prior to inspection.
- Due to unforeseeable construction design, all head locations to be field verified for compliance.

Schedule your inspection online through the city of puyallup online permit system. This is a request for inspection only. A date and time will be selected by Inspector depending on availability. Email morning of inspection between 7am – 8am for scheduled date and time. Fire Inspections are Monday – Thursday there will be no inspections on Fridays. For larger system please make an appointment prior to scheduling first.
