- Hydro test will be required on all new and existing buildings. Appointment required.

- Hydro test, two inspections will be required 2hrs apart. Call to schedule times. Am/pm is not guaranteed without appointment.
- Tool kit required at time of final.
- NFPA placards required.

Schedule your inspection online through the city of puyallup online permit system. This is a request for inspection only. A date and time will be selected by Inspector depending on availability. Email morning of inspection between 7am – 8am for scheduled date and time. Fire Inspections are Monday – Thursday there will be no inspections on Fridays. For larger system please make an appointment prior to scheduling first.
