On behalf of Seattle SMSA Limited Partnership d/b/a Verizon Wireless ("Verizon Wireless" or "Applicant"), Crown Castle USA Inc. ("Crown Castle") is submitting this letter to address comments received May 5, 2025 regarding permit application PRCTI20250387.

1. Please confirm that this last column is the equipment weights. If so, please verify the listed weight of the new and existing equipment as they appear to be far less than what is specified by the manufacturers. Typical. [Reference the marked up document: STRUCTURAL CALCS, page 13 of 49] [0387 STRUCTURAL CALCS; 2025\PRCTI20250387\880329\_670680\_SA.pdf; pg. 13]
  - Response: The last column is not equipment weights. *Eh* represents the horizontal seismic load effect, specifically the effect of horizontal forces generated by an earthquake which can generate shear. Individual equipment weights are not specifically called out in the Structural Analysis.
2. Please verify the weight of the antenna. The manufacturer's antenna specifications sheet notes the antenna's weight as 308.6lbs. [Reference the marked up document: CONSTRUCTION PLAN SET, sheet C-5] [CONSTRUCTION PLAN SET ; 2025\PRCTI20250387\880329\_670680\_CDs v2.pdf; pg. 7]
  - Response: Antenna's listed weight of 308.6lbs is accurate.
