- Correct public roadway name to E PIONEER in all instances on all sheets. [TCP; 2025\PRROW20251149\TCP 1.pdf; pg. 2]
- Provide a copy of "TCD00" in the next submittal or update note reference on all sheets. [TCP; 2025\PRROW20251149\TCP 1.pdf; pg. 2]
- Place a ROAD WORK AHEAD (W20-1) advanced warning sign for northbound traffic on the WB and EB SR512 TO E PIONEER OFF-RAMPS. [TCP; 2025\PRROW20251149\TCP 1.pdf; pg. 2]
- Allowed closure times listed in this table do not match the table from the WSDOT Maintenance of Traffic (MoT), Section 2.22.4.3.3.1. Please update table on both TCPs to match the approved MoT tables. Add a note to the table indicating how many times the closure may be implemented per the MoT. Moreover, include the Extended Weekend Ramp Closure tables with a note on how many times the closure may be implemented per the MoT. [TCP; 2025\PRROW20251149\TCP 1.pdf; pg. 2]
- For all sheets, place channelization devices across closed on ramp in accordance with WSDoT standard TCP TC13. [TCP; 2025\PRROW20251149\TCP 1.pdf; pq. 2]
- Place a "2" DETOUR sign (M4-9L MOD) for northbound traffic on N MERIDIAN in advance of the SR 167 on-ramp. [TCP; 2025\PRROW20251149\TCP 1.pdf; pg. 5]
- Add a note to all TCP pages stating that all TCPs and work shall comply with the final or most recently adopted Washington State Department of Transportation Maintenance of Traffic agreement for the SR 167/SR 161 to SR 410 Rebuild Interchange Project. Furthermore, add a note that consecutive off-ramps or consecutive on-ramps shall not be closed concurrently unless approved by the WSDOT Engineer. [TCP; 2025\PRROW20251149\TCP 1.pdf; pg. 2]
- The WSDOT Maintenance of Traffic (MoT), dated January 17, 2024, includes redlines, watermark, other markups that indicate it is not an official or final copy. Please submit a complete and final/most recently adopted version of the MoT for consideration and to verify the listed closure hours. Please submit the MoT as a separate document. Do not include it in the traffic control plan document. [WSDoT MoT SR 167 to SR 410; 2025\PRROW20251149\WSDoT MoT SR 167 to SR 410.pdf; pg. 1]

Conditions
