| <p>- Add a note on all TCP pages (or revise the first note on TCD00) stating that all TCPs and work shall comply with the final or most recently adopted Washington State Department of Transportation Maintenance of Traffic agreement for the SR 167/SR 161 to SR 410 - Rebuild Interchange Project. Furthermore, add a note that consecutive off-ramps or consecutive on-ramps shall not be closed concurrently unless approved by the WSDOT Engineer. [TCP; 2025\PRROW20251189\TCP1.pdf; pg. 3]</p> <p>- Merge SB left turn lanes on N MERIDIAN into a single lane prior to intersection since an EB lane on VALLEY AVE is closed east of the intersection. Moreover, for all TCP sheets, provide advanced warning signs in all directions in advance of work zone. Please include all applicable tables on all sheets and compare overlapping work hours. If applicable, add a note to the table indicating how many times the closure may be implemented per the MoT. Moreover, include a note that if the lane closure is adjacent to an Auxiliary Lane, the affected ramp shall be closed concurrently and the allowable hours for the ramp closure shall apply. - It may be possible to avoid the long detour on Todd RD, which is in disrepair and heavily residential, if NB vehicles are allowed to turn EB on Valley. If the inside WB-L turn lane is shut, possibly along with the NB outside lane, there may be sufficient radius for turning movements here.
