Adjust stormwater report to reflect Ecology's 2019 stormwater Manual.

MR 5 incomplete Not all list 1 BMPs were considered. Missing rain gardens, bioretention, and concentrated sheet flow.

The narrative for what is proposed appears incomplete. The plans and an exhibit show asphalt removed for landscape, but there is no narrative describing this or how much is being removed. I am assuming the intent is no net increase in PGHS on the existing storm system?

- Provide a document nullifying the existing gate agreement. This document should provide a signature block for the property owner and the City's Developement and Permitting Services Manager.

Provide a document agreeing to the closure of the Valley Ave access gate, which requires the access to remain closed at all times, secured with a knox box for emergency vehicle access only.

Add a note to the civil plan set referencing the agreement on file with the City which prohibits the use of the access gate on Valley Ave.

The submittal shall only be considered complete if the information requested above is received by the City of Puyallup within 90 days of date of this letter and deemed satisfactory by the Permit Center. Otherwise, your permit application will be canceled, and you will need to apply for a new permit. Once
