Description of Work Two part project utilizing existing EST3 fire alarm system supporting Vesda detection and pre-action releasing for datacenter property. EST3 system is interfaced with house notifier system. House system is covers notification, HVAC interfaces, and other emergency control. Part 1: Fire repair for existing battery room Existing battery room damage by fire, all devices and wiring to be replaced like for like in existing locations with existing function. Tenant is increasing the size of the battery room and as such, the Vesda aspirating detection pipework shall be extended accordingly. Part 2: New battery room & battery type change A small ups/battery room is being added, Vesda detection is provided for new battery room. All battery rooms, including room damaged by the fire and existing unchanged battery room, to be provided with battery charger shutdown to activate upon Vesda fire detection.

Standard Conditions:

1. • Appointment required for all inspections am/pm is not guaranteed without appointment. Larger systems taking more than 1 hour will require 48-72hr notice prior to scheduling.
 - Provide plans and permit on site for inspection.
 - Complete labor and industries inspections prior to requesting city inspection.
 - If there is an existing annunciator on the exterior of the building it will need to be moved inside the main entrance.
- Please contact fire inspector for further information.
- Exterior fire bell required outside fire sprinkler room.
 - Above ceiling detection is required.
 - Device maps required at the annunciator and fire alarm panel prior to calling in final. The annunciator map will need to be weatherproof.
 - Total coverage is required, subject to field inspection. Comply with NFPA 72.
 - Fire alarm system shall be placarded per NFPA 72. The UL certificate shall be posted at time of final inspection. The system will need to be UL certified.
 - Pre-test shall be conducted with a printout for inspector at time of inspection.
 - Labeling of all devices above and below ceiling required.
 - Fire sprinkler tamper valves and PIV will be required to be tested at inspection. Fire sprinkler contractor to be onsite.
 - RTU'S and smoke dampeners will be required to be tested during inspection. RTU'S of 2000cfm or higher are required to be monitored and will require shutdown.
 - The city of Puyallup allows one FACP per building. The panel will need to be large enough to handle multiple tenants if applicable.
 - In existing buildings all above ceiling detection is to remain. Do not remove.
 - Due to unforeseeable construction design, all device locations to be field verified for compliance.
- Schedule your inspection online through the city of puyallup online permit system. This is a request for inspection only. A date and time will be selected by Inspector depending on availability. Email morning of inspection between 7am – 8am for scheduled date and time. Fire Inspections are Monday – Thursday there will be no inspections on Fridays. For larger system please make an appointment prior to scheduling first.
