- 6- Hydro test, two inspections will be required 2hrs apart. Call to schedule times. Am/pm is not guaranteed without appointment
- 7- Fire pumps will be required to be tested and witnessed by inspector.
- 8- Tool kit to be available at time of final.
- 9- NFPA placards required
- 10- In existing buildings all upright fire sprinklers to remain, do not remove.

Schedule your inspection online through the city of puyallup online permit system. This is a request for inspection only. A date and time will be selected by Inspector depending on availability. Call morning of inspection between 7am – 8am for scheduled date and time. Fire Inspections are Monday – Thursday there will be no inspections on Fridays.
