- 4- Contractor required at all inspections.
- 5- Hydro test will be required on all new and existing buildings. Appointment required.
- 6- Hydro test, two inspections will be required 2hrs apart. Call to schedule times. Am/pm is not guaranteed without appointment
- 7- Fire pumps will be required to be tested and witnessed by inspector.
- 8- Tool kit to be available at time of final.
- 9- NFPA placards required
- 10- In existing buildings all upright fire sprinklers to remain, do not remove.

Schedule your inspection online through the city of puyallup online permit system after requesting appointment from inspector. Fire Inspections are Monday – Thursday there will be no inspections on Fridays.
