- ♦ Add ROAD WORK AHEAD sign for northbound 7TH ST SW before 39TH AVE SW [TCP, 39TH AVE SW @ 5TH ST SW].
- ♦ Correct all instances of 96TH AVE E to 7TH ST SW [TCP, 39TH AVE SW @ 5TH ST SW].
- ♦ Correct all instances of 96TH AVE E to 7TH ST SW [TCP, 39TH AVE SW @ 5TH ST SW].
- ♦ Add ROAD WORK AHEAD sign for northbound 7TH ST SW before 39TH AVE SW [TCP, 39TH AVE SW @ 5TH ST SW].
- ♦ Correct all instances of 96TH AVE E to 7TH ST SW [TCP, 39TH AVE SW @ 5TH ST SW].
- ♦ Correct all instances of 94TH AVE E to 9TH ST SW [TCP, 39TH AVE SW @ 94TH AVE E].
- ♦ Correct all instances of 96TH AVE E to 7TH ST SW [TCP, 39TH AVE SW @ 96TH AVE E].
- ♦ Correct all instances of 94TH AVE E to 9TH ST SW [TCP, 94TH AVE E @ 39TH AVE SW].
- ♦ According to the site plan, MH 122 is located in the intersection. Revise the location of the manhole and adjust the corresponding traffic control configuration [TCP, 94TH AVE E @ 39TH AVE SW].
