• The valuation of this application allows the City of Puyallup to require improvements within the City's right of way. The City is concerned the existing design of 14th St SW is not adequate to accommodate future development in the area. In order or to maintain safe and efficient ingress/egress for Costco (and for future development) the City has been exploring options to retrofit the existing 14th St SW residential cul-de-sac with a functional roundabout. This concept (see attached pdf) would help minimize future operational & safety concerns, and improve site circulation for the existing Costco parking lot. For the current building permit application, In-lieu of any actual site improvements or construction, the City will require the applicant to evaluate/design this concept and to identify any ROW dedication needs (from Costco) to facilitate these necessary access improvements. Once the ROW needs have been determined, the City will require dedication as a condition of this building permit. Sheet G1
