• It is the city?s opinion that a further effort onyour part is required to place your utilityunder the sidewalk. This may require that youremove sidewalk panels and/or pothole them. This can be accomplished only by obtaining apermit first.Sheet Number: 1 of 18

• Vault will not be placed in a lane of travel. Sheet 9 of 18

• Can vault be placed at back of sidewalk? Is there a utility easement that Zayo Group can participate in? Sheet 12 of 18

• Relocate vault, shift it near the northerly edge of ROW. Sheet 16 of 18

• Each and every submittal must match the one prior too. While the number of pages did not change, the order of the pages did change. You will note that all stamps and comments no longer line up as they should. For example a comment made on the last review may have been about a certain vault. The comment's arrow leader pointed to that vault. In the most current submittal that comment about the vault now points to something else because the page has changed. Another example, the permit number was stamped on each of the 18 pages. They were placed in such a way to not interfer with the drawing.
