NOW, THEREFORE, if the said Principal shall during the continuance of such permit or permits faithfully perform and comply with all of the provisions of said permit or permits and shall indemnify and hold harmless PIERCE COUNTY, THE COUNCIL OF PIERCE COUNTY and the STATE OF WASHINGTON from any and all claims, actions or damages of every kind and description which may accrue to or be suffered by any person or persons, corporations or property by reason of the performance of such work, character of materials used or manner of installation, maintenance and operation or by the improper occupancy of rights of way or public structure, and in case any suit or action is brought against said PIERCE COUNTY, THE COUNCIL OF PIERCE COUNTY, and the STATE OF WASHINGTON, for damages arising out of or by reason of any of the above causes, the Permittee, its successors or assigns will upon notice to it of commencement of such action, defend the same at its own sole cost and expense and will satisfy any judgement after the said suit or action shall have finally been determined if adverse to the STATE OF WASHINGTON, then and in that event this obligation shall be void; but otherwise it shall be and remain in full force and effect.

This obligation is applicable to the period commencing January 15th, 2026 and ending January 15th, 2027 but may be cancelled by the surety by its giving ten days written notice to the Principal and PIERCE COUNTY, THE COUNCIL OF PIERCE COUNTY and the STATE OF WASHINGTON.

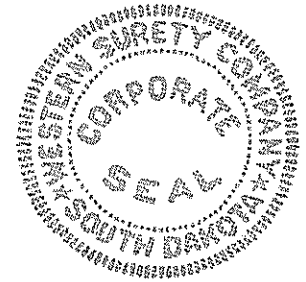

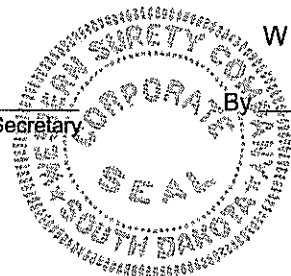

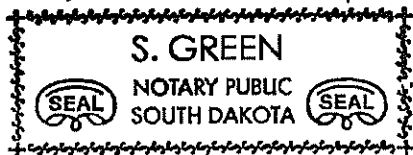
