<p>- LAST REVIEW CORRECTION: The City of Puyallup does not review, authorize, or permit private utility work on private property. Relocate pedestal to public right-of-way or remove from scope of franchise utility permit. It is the franchise utility's responsibility to obtain the necessary permissions from the impacted private property owner(s).</p> <p>CURRENT REVIEW CORRECTION: The established right-of-way limits should not be shifted or exaggerated to accommodate an existing, noncompliant pedestal location. Return the right-of-way limits to those depicted on the last submittal. Then consider removing pedestal upgrade from scope of City permit, obtaining a retroactive easement for utilities previously installed on private property, or replacing the pedestal upgrade on the site plan with a note that says the work will continue on private property as permitted by the private property owner.
