<p>- The area of the proposed sign (30 sq. ft.) exceeds the maximum area permitted for this tenant space. The maximum permitted area for this tenant space is 16.58 sq. ft. Please correct the proposed sign area.</p> <p>Per PMC 20.60.047 (1), "Special provisions for the CCX, CMX, LMX, RMX, and UCX zones", the maximum permitted area for facade signs in the RMX zone is calculated as 1 sq. ft. for each lineal foot of the building wall from which the sign is attached. Please refer to PMC 20.60.037 (1)(a), "Specific sign requirements by use", which identifies how the City of Puyallup determines maximum sign area.</p> <p>PMC 20.60.037 (1)(a):</p> <p>(1) Development Complexes. Signs within a development complex shall be subject to the following requirements:</p> <p>(a) Business Signs. Each institution or business shall be permitted facade signs and no more than one projecting sign subject to the maximum size requirements set forth for the applicable zone. The tenant space width shall be used to determine maximum sign area; a tenant located in a floor above lower tenants may count the same wall length in determining allowable facade signage.</p> <p>See "SIGN PERMIT SUBMITTAL DOCUMENTS", sheet 2 of 2.
