[Comment Correction; ; pg. N/A]</p> <p>- Sheet 5 of site plan now depicts work at the utility pole on W PIONEER at the intersection of S FRUITLAND (public). Based on this lane configuration, this traffic control appears to be at the intersection of W PIONEER and CORWIN RD (private) with CORWIN RD mislabeled as S FRUITLAND (private). Update the TCP to match the location depicted on sheet 5 of the site plan. [TCP - RESUB; 2026\PRFUP20251621\6020679_TCP_REV.pdf; pg. 7]</p> <p>- Replace "STREET NAME" with the actual street name. [TCP - RESUB; 2026\PRFUP20251621\6020679_TCP_REV.pdf; pg. 17]</p> <p>- The utility pole at the corner of W PIONEER and 12TH ST SW was not previously included. Remove from site plan scope or provide a corresponding TCP for this location. Any additional sheets to the TCP should be added at the end of the document. Resubmitted TCP should maintain same page order upon resubmission with new pages inserted at the end. [SITE PLAN - RESUB; 2026\PRFUP20251621\6020679_SP_Rev1.pdf; pg. 6]</p> <p>- Change SP to TCP.
