In order to review an application for a civil construction permit, the City of Puyallup Engineering Services requires the following information:

- 1 completed Application Form – signed and dated.
- 8 sets engineering designed drawings as per City Standards Section 2.0 General Plan Requirements.
- 1 CD of the designed drawings in pdf format.
- 2 sets Technical Information Reports (TIR), which may include:
 - Storm drainage calculations
 - Soils engineering reports
 - Geotechnical reports
- 2 sets landscape plans overlaid with the proposed utility plan (if applicable)
- Wetland Reports / Delineation Plans (if applicable)

REVIEW FEES

Commercial / Multi-Family Projects / Major Plat / Short Plat:

- Plan review and record drawing review fee: \$670.00

Off-site – water/sewer/storm main extension / grease interceptor / oil water separator:

- Plan review and record drawing review fee: \$560.00

Clear, Fill and Grade:

Plan review plus \$200 record drawing review fee:

- Clearing only - \$70.00
- 0-50 cubic yards - \$130.00
- 51-100 cubic yards - \$240.00
- 101-1,000 cubic yards - \$510.00
- 1,000-10,000 cubic yards - \$760.00
- 10,001-100,000 cubic yards - \$1,000.00
- 100,001 cubic yards and up - \$1,240.00
