THIS INDENTURE WITNESSETH: That the Puyallup & Sumner Packing Company, a corporation, the party
of the first part, in consideration of \$1.00 and other good and valuable consideration to it in hand paid
by the City of Puyallup, the party of the second part, the receipt whereof is hereby acknowledged, does
by these presents, give and grant unto the said party of the second part, the right and privilege to
maintain, repair and renew an 8 inch cast iron water main as now constructed along a line located

298 feet north from and parallel to the center line of the east bound
main line track of the Northern Pacific Railway Company, between the
limits of the west line of tract 34 extended south and the east line
of tract 38 extended south, said tracts herein referred to being as
designated upon a certain plat entitled "Replat of a Part of Frank R.
Spinning's First Addition to the City of Puyallup, Pierce County,
Washington."

TO HAVE AND TO HOLD until the 1st day of November, 1977, and so long thereafter as the first
party, its successors or assigns shall have control of the premises over which said water main is
constructed.
