Just doing my due diligence i.e. annual reporting. Please see the new document attached. No changes for ACT - A Common Thread still doing the "mobile" food distribution via our refrigerated truck under emergency management and farmer markets to senior living facilities. Updated in 211.

We are working towards a storage warehouse for dry goods and the ability to do smaller portions packaging for seniors such as rebagging grapes and fruit but it is under construction. Projected soft opening Nov 2023. Still a lot of painting and cosmetic stuff going on, Grants are projected for the end of August 2022 for cool room, freezers ect... I am sure there will be requirements once we are able to move forward with these projects and funding is secured.

Thank you for speaking with me today about your operation. Based on our discussion your operation will be classified as a Donated Food Distributing Organizations. Under this designation, you will need to have a 501 (c) and are required to register annually with the local Health Department but a permit or fee are not required. WAC 246-215 Chapter 9 subpart D references the requirements for Donated Food Distributing Organizations. The WAC is available online at <https://www.doh.wa.gov/Portals/1/Documents/Pubs/332-033.pdf>

You will need to complete the attached survey so we can create a new file for you. This survey is used for all donated food distributing organizations and helps us understand what equipment and sinks are available at your location. We use this information and your menu to ensure the minimum health code is being met. Once you return the completed survey, we will create a file and reach out to you if we have additional questions or concerns.

As we discussed, I have refunded the temporary food establishment permit that you submitted that was not needed.
