PROJECT DESCRIPTION	Standalone SEPA application for a second minor modification to the original approved Conditional Use Permit (P-18-0154). The previous minor modification (P-21-0116) included a request to refurbish and reuse an out-of-service tank ("Tank 3") for additional storage/segregation of used motor oil. This current minor modification request is to reuse two existing tanks and place the tanks in service within an oil tank containment area. The two tanks are approximately 54 feet in height and are 20,000 gallons each. The size of the project is under 1,000 square feet. Minor modifications to sites and structures under a valid conditional use permit may be administratively reviewed by the Director, subject to the findings of PMC 20.80.031.

- The parking landscaping, and sodded area all appear to have been installed previously as part of other permits, but are labeled as "to be...". Please call out what is existing and what is proposed. [site plan, C1.0]
- Will the interior be remodeled as part of this minor modification or has this work been completed already? [site plan, C1.0]
- Please submit an Accidental Spill Prevention/Slug Discharge Plan (ASSP) for this proposed minor modification that includes the utilization of tanks 5 & 6.
- Please submit an Emergency Action Plan for this proposal.
- The project is located within a Critical Area Aquifer Recharge Area. A CARA report and addendum were prepared in 2014 for the original Conditional Use Permit (P-18-0154) and was submitted as part of this minor modification submittal. This CARA report appears to have reviewed the site comprehensively. Please have your critical area consultant provide a memo to affirm that is the case and whether any additional measures are required for protection of the critical aquifer recharge area by bringing additional tanks (tanks 5 & 6) into use on site. Also, please provide an updated Spill Prevention, Control, and Countermeasure Plan.
- Your SEPA Checklist states that tanks 5 & 6 will allow for the use of segregating used oil by product quality (like moisture content) and reduce transportation costs required for co-mingled products by adding storage capacity to the site. Can you please provide more information on the need for the utilization of tanks 5 & 6 and why they were not used previously? Will their use and materials being stored be similar to tank 3, which was permitted through the last minor modification (P-21-0116)? The letter prepared by EcoLube LLC (06/08/2023) and the letter prepared by ChemE Consulting (05/30/2023) describe the scope of work and the proposed uses, however, confirmation of the proposed material being stored is helpful.
