The proposed action will adopt an amendment to the zoning code to clarify that methadone clinics are prohibited in the MX Mixed Use Zone chapter. Allowances for methadone clinics were previously reviewed in 2016 and are permitted only in the MED Medical zone. An oversight resulted in this code section being silent as to whether methadone clinics are allowed or prohibited; this clean-up will clarify that the clinics are prohibited in these zones.
