Archaeological site 45PI01647, an isolated jasper lanceolate biface hafting element with a snap fracture, was observed in shovel probe 26 at 35cmbs in the northwest portion of the project. Delineation of this isolated artifact did not result in the observation of additional archaeological resources. Antiquity Consulting recommends the artifact be donated to the Puyallup Tribe of Indians. The project should comply with an inadvertent discovery plan because there is risk of encountering isolated artifacts in this area.
