Description of Proposal: Proposal to adopt the "City of Puyallup Commute Trip Reduction

Four-Year Plan Update: 2025-2029" and amend the Puyallup Municipal Code (PMC) Chapter 21.16 - Commute Trip Reduction (CTR) Program. The CTR plan outlines policies and strategies to reduce single-occupant trips through employer-based transportation programs that incentivize alternative transportation. The CTR plan and associated code were developed to meet the requirements of the Washington State Commute Trip Reduction Act (RCW

70A.15.4000-4080). The CTR program is a policy guiding document that outlines the strategies for the City of Puyallup to implement and

assist employers in meeting the goals of the plan.

Location of Proposal: This is a non-project SEPA determination (not site-specific). The

proposed updates to the Puyallup Municipal Code and CTR Plan will apply to the City of Puyallup and other CTR-affected employers within City of Puyallup limits, consistent with Section 70A.15.4020 of

the Revised Code of Washington (RCW).

## PROJECT SPECIFIC MATERIALS (INCORPORATION BY REFERENCE - WAC 197-11-635):

- 1. The subject Threshold Determination herein and associated environmental findings are based upon review of the following documents submitted by the applicant and official responses from the city in regard to the underlying permit(s). These documents are incorporated by reference, in accordance with WAC 197-11-635, and are available for public review on the City's online permit portal.
  - SEPA Checklist/Non-Project Action Checklist, completed by the Planning Division. Dated May 15, 2025.
  - ii. Final Draft City of Puyallup Commute Trip Reduction Four-Year Plan Update: 2025-2029.
  - iii. Draft Puyallup Municipal Code Chapter 21.16 amendments.
- 2. The City submitted the Draft CTR Plan for review by the Washington State Commute Trip Reduction Technical Committee on February 19, 2025. The technical committee approved the City's plan on April 3, 2025.
- 3. The City submitted the Draft CTR Plan for review by the Puget Sound Regional Council on February 19, 2025. PSRC confirmed the Plan's consistency with the Regional Transportation Plan (2022-2050) on May 30, 2025.
- 4. Puyallup City Council is anticipated to consider first reading of an ordinance for the adoption of the updated CTR Plan and proposed amendments to Chapter PMC 21.16 at a public meeting on June 17, 2025.
- 5. A summary of the amendments proposed, including key environmental issues addressed and associated findings made during the threshold determination process, is as follows:
  - i. Draft City of Puyallup Commute Trip Reduction Four-Year Plan Update: 2025-2029. The Draft CTR Plan covers the benefits of CTR programming, connections to the City's Land Use and Transportation policy objectives, alignment with transit plans, performance targets for the City and employers who must comply under Washington State's CTR law, services and strategies for meeting the targets, community engagement, and planned funding for services and strategies.
  - ii. Draft PMC Chapter 21.16 Commute Trip Reduction Program. The proposed code changes will incorporate the updated CTR Plan and provide code consistency with current Washington State CTR requirements. Updates are proposed to all sections of the Chapter 21.16 PMC and the updates include, but are not limited to: elimination of outdated information or practices; the addition of a new purpose and intent section; updates to administrative practices, definitions, affected employer CTR program and reporting requirements, references to teleworking and telecommuting; and updating Revised Code of Washington (RCW) references to reflect the recodification of RCW 70.94.521 through RCW 70A.94.551 as sections in Chapter 70A.15 RCW.
  - iii. The proposed plan and code amendments apply citywide and aim to reduce congestion and impact on the transportation system through the implementation of CTR strategies. The plan also aligns with transit plans. The associated code amendments will aid in the implementation of the CTR program.

# **DETERMINATION OF NON-SIGNIFICANCE (DNS)**

Upon review of applicable documentation, the responsible official of the lead agency hereby finds that this proposal would not result in a probable significant adverse impact on the environment. The lead agency has determined that the requirements for environmental analysis, protection, and mitigation measures have been adequately addressed in the development regulations and comprehensive plan adopted under chapter 36.70A RCW, and in other applicable local, state, or federal laws or rules, as provided by RCW 43.21C.240 and WAC 197-11-158. Our agency will not require any additional mitigation measures under SEPA.

An Environmental Impact Statement (EIS) is not required, under RCW 43.21C.030 (2) (c). This finding is made pursuant to RCW 43.21C, PMC 21.04.120 and WAC 197-11 after reviewing a completed environmental checklist and other information on file with the lead agency. The responsible official finds this information reasonably sufficient to evaluate the environmental impact of this proposal. This information is available to the public upon request.
