Hi Nabila,

Thanks, that's a great question!

Assuming 2.54 persons per dwelling unit and including the proposed and existing residences, creating this pedestrian connection would **provide transit access to approximately 163 residents and facilitate 880 annual boardings**.

For planning purposes, we consider dwellings that are 0.5 miles from a transit stop to have transit access. While the ITE manual assigns a portion of total trips as transit trips, we looked at average ridership per dwelling unit within 0.5 miles along the routes that serve the South Hill Mall Transit Center (4, 400, 402) to estimate the above.

It also looks like some of the policies in the 2015 Comprehensive Plan and Puyallup Moves could support a connection like this one.


