FEIS Addendum Description:

The purpose of the FEIS addendum is to provide additional environmental analysis and updated information related to proposed amendments to the Puyallup 2044 Comprehensive Plan since issuance of the FEIS. The proposed amendments include four (4) Future Land Use Map changes that modify the Preferred Alternative of the FEIS. Therefore, the FEIS

Addendum documents the proposed changes, includes additional analysis to evaluate the environmental impact of the proposed changes, and adds one new mitigation measure to address those changes while maintaining consistency with the

original Final EIS.

Original FEIS Proposal: The City of Puyallup is required to review and update its

Comprehensive Plan every 10 years to meet the requirements of the Washington State Growth Management Act (GMA), Revised Code of Washington (RCW) Chapter 36.70A, and other regional policies. The proposed major update of the Comprehensive Plan, known as Puyallup 2044, will set the vision for the city for the

next 20 years. The Periodic Update includes proposed

amendments to all thirteen plan elements. The FEIS contains environmental analysis of four plan alternatives, including a Preferred Alternative, and identification of impacts and mitigation

measures. In addition to the policy amendments to the Comprehensive Plan, the City will review the implementing development regulations and propose modifications consistent July 10, 2025 Notice of Availability

with the policy changes following the Puyallup 2044

Comprehensive Plan adoption.
