Date of Issuance: February 22, 2022

Description of Proposal: This non-project action is the City of Puyallup's Shoreline Master

Program (SMP) periodic update and associated amendments to PMC Title 21.06. The update is intended to ensure that the City's SMP complies with changes in state law, remains consistent with Puyallup plans and regulations, and responds to changed circumstances and new information. The update also includes changes to improve clarity of shoreline and critical area permitting procedures. Amendments to PMC Chapter 21.06 include changes to wetland criteria as well as adding references the SMP and

shorelines of the State.

Location of Proposal: This is a non-project SEPA determination (not site-specific). The

Shoreline Master Program applies to all areas of Puyallup within the shoreline designation. PMC Chapter 21.06 applies to all critical

areas in Puyallup.

#### FINDINGS AND CONCLUSIONS

The SEPA Responsible Official for the City of Puyallup hereby makes the following findings and conclusions based upon a review of the environmental checklist and attachments, other information, and studies on file for the project, and the policies, plans and regulations designated by the City of Puyallup as a basis for the exercise of substantive authority under the State Environmental Policy Act (SEPA) pursuant to the Revised Code of Washington (RCW) 43.21C:

#### **NON-PROJECT ACTION**

The Responsible Official offers the following analysis and conclusions related to this non-project SEPA action:

- The proposed amendments would ensure that the Puyallup SMP continues to comply with the Shoreline Management Act (SMA), as required under RCW 90.58.090(4). This includes changes such as clarifying language, an updated cost threshold for substantial development, updated definitions, added references to the WAC, and details on moratoria authority and procedures.
- The proposed amendments would improve the accuracy and clarity of the Puyallup SMP by updating external references and improving document organization and formatting.
- The proposed SMP amendments would prohibit treated wood and chainlink fencing in the shoreline jurisdiction, improving ecological functions and habitat.
- The proposed SMP amendments would make granting and denying Shoreline Substantial Development Permits Shoreline Administrator responsibilities instead of Hearing Examiner authority.
- The proposed amendments to PMC Chapter 21.06 would:
  - Use best available science for wetland criteria by adding further restrictions on exceptions, consistent with Department of Ecology guidance.
  - o Improve clarity regarding shorelines of the state and SMP applicability.
  - Update the wetland mitigation ratios for preservation of wetland areas by referencing the most current Ecology guidance (note: alternative code text option).
- This non-project action is not anticipated to cause significant impacts to the environment. Any future development project(s) in the shoreline jurisdiction and/or impacting critical areas will also be subject to applicable development standards, site-specific environmental review, and compliance with Puyallup Municipal Code Title 21 Environment.

#### **DETERMINATION OF NON-SIGNIFICANCE (DNS)**

Upon review of applicable documentation, the responsible official of the lead agency hereby finds that this proposed permit action would not result in a probable significant adverse impact on the environment. The lead agency has determined that the requirements for environmental analysis, protection, and mitigation measures have been adequately addressed in the development regulations and comprehensive plan adopted under chapter 36.70A RCW, and in other applicable local, state, or federal laws or rules, as provided by RCW 43.21C.240 and WAC 197-11-158. Our agency will not require any additional mitigation measures under SEPA.

An Environmental Impact Statement (EIS) is not required, under RCW 43.21C.030 (2) (c). This finding is made pursuant to RCW 43.21C, PMC 21.04.120 and WAC 197-11 after reviewing a completed environmental checklist and other information on file with the lead agency. The responsible official finds this information reasonably sufficient to evaluate the environmental impact of this proposal. This information is available to the public upon request.
